**VOLUNTARY ANNOUNCEMENT
SHARE REPURCHASE**

This is a voluntary announcement made by Dongyue Group Limited (the “**Company**”) to provide its shareholders and potential investors with update information in relation to the development of the Company.

The board of directors (the “**Board**”) of the Company wishes to inform the public that on 26 August 2015, the Company repurchased, on The Stock Exchange of Hong Kong Limited, 250,000 ordinary shares of the Company (the “**Share Repurchase**”). The aggregate consideration for the Share Repurchase is approximately HK\$448,900 which is funded from internal resources of the Company. Up to the date of this announcement, the Company has repurchased a total of 4,776,000 of its own shares pursuant to the repurchase mandate granted to the Board at the annual general meeting of the Company held on 1 June 2015 (the “**Repurchase Mandate**”), representing approximately 0.225% of the issued share capital of the Company.

The Company may or may not repurchase additional shares under the Repurchase Mandate, subject to the market condition and such decision will be at the Board’s absolute discretion. The Company may repurchase its shares at any price as determined by the Board, subject to the applicable rules under the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited. There is no assurance of the timing, quantity or price of any share repurchases or whether the Company will make any further repurchases at all. Shareholders and investors should therefore exercise caution when

dealing in the shares of the Company.
