VOLUNTARY ANNOUNCEMENT APPROVAL OBTAINED FOR THE CONSTRUCTION OF A NEW PVDF PROJECT WITH A PRODUCTION CAPACITY OF 10,000 TONNE PER YEAR

This Announcement is made by Dongyue Group Limited (the "Company", together with its subsidiaries the "Group") on a voluntary basis.

Recently, Shandong Huaxia Shenzhou New Material Co., Ltd. (山東華夏神舟新材料有限公司), a subsidiary of the Company, has obtained all approvals for a PVDF project with a production capacity of 10,000 tonne per year (the "**Project**"), the construction of which is about to commence. The Project is another important product of the Group focusing on new battery-level PVDF in addition to coating-level PVDF, water treatment membrane-level PVDF and solar panel membrane-level PVDF. The construction of the Project is expected to complete in October 2022 with operation starting at the same time.

After the Project is completed, the production capacity of PVDF for lithium ion battery will reach 10,000 tonne per year, and the Group's production capacity of PVDF resin will reach 25,000 tonne per year, covering all mainstream product grades, thus achieving full coverage in various product categories, such as lithium battery, photovoltaic, coating and water treatment.
